**1. Start of the Collaborator/Organizer relationship is: 6 September 2020**

### **3. Scope of Cooperation:**

The Collaborator is engaged as an Event partner at Green Days, a flower market concept.

#### **Engagement includes:**

Preparing their stand for the start of the event by **10h30am**.

Managing their stall for the duration of the event.

Adhering to COVID safety measures during market duration.

Packing up their products and removing their goods from the premises by the end of the market day by **8pm**.

### **4. Responsibilities of Collaborator:**

The Collaborator is responsible for the condition of their stand from the beginning to the end of the market.

The Collaborator will be considerate of the inhabitants of the event area.

The Collaborator must present a company, event, and/or personal liability insurance policy which covers personal injury and damage caused by the Collaborator, his/her employees or his/her guests.

### **6. Liability Waiver**

This agreement releases the Organizer and it's co-hosts and associates from all liability relating to injury, damage to goods or monetary loss that may occur on or during the event.

By signing this agreement, the signee agrees to hold the Organizer and it's co-hosts and associates entirely free from any liability, including financial responsibility for injuries or losses incurred, regardless of whether injuries are caused by negligence.


## **7. Cancellation and Force Majeure**

The Organizer reserves the right to cancel the event in consequence of Act of God including but not limited to natural disaster, pandemic, strike, lock-out, labour dispute, terrorist act, and the Organizer will not be liable to the Collaborator for expenses already incurred. The event and stand fees will then be postponed to a later agreed upon date.

## **8. Severability**

If any provision of this agreement is held by a court of law to be illegal, invalid or unenforceable, (a) that provision shall be deemed amended to achieve as nearly as possible the same economic effect as the original provision, and (b) the legality, validity, and enforceability of the remaining provisions of this agreement shall not be affected or impaired thereby.
